The TEA Financial Accountability System Resource Guide requires Board approval for any change to a revenue object or a function expenditure category. The attached proposed amended budget and the individual amendments reflect these changes.

Impact Statement: General Operating fund expenses increased by \$135,800 to help cover an upgrade to the District's EDULOG software system for Transportation. All other amendments were direct offsets between different functions. Approval of these amendments will result in a \$135,800 decrease to the General Operating fund balance.

Capital Projects expenditure amendments include \$423,764 for Chiller Replacements at Mayde Creek, Morton Ranch and Seven Lakes High Schools approved by the Board of Trustees in October 2023, resulting in no change to Construction Fund Balance.

The Payroll Department has been in partnership with our current time management vendor for over 20 years. However, after careful consideration of recent price increases and required software upgrades, the department made a decision to begin a search for a new service provider. The department invited various time and attendance vendors to demonstrate their products. After a thorough evaluation, TimeClock Plus (TCP) was found to provide the best overall value for fulfilling the Districts Time and Attendance needs.

As per Board Policy<u>EH (Local)</u>, curriculum changes that may involve the addition or deletion of courses may be initiated by the Board or administration and may be made only after approval by the Board". Courses are reviewed annually and additions and deletions are presented to the Board for approval. Therefore, each year, the Division of Teaching and Learning facilitates the process of course review including soliciting input from central and campus staff regarding course additions and deletions for the following year. As requests are received, the Division assesses the content of the course, availability of curriculum, highly qualified staff, student interest, alignment to the TEKS, and relevance to the District Strategic Plan.

Guiding questions include:

- Is the content overlapping/repetitive with other courses?
- · How does a course offering align with the state graduation requirements?

Goals : Katy ISD will develop systems where customized resources will ensure equity in response to the needs of a growing district with rapidly changing demographics.

The \$676 Million Bond Authorization provides funding for the design services for the cafeteria kitchen component replacements at King Elementary, Schmalz Elementary, Williams Elementary, Katy Junior High, Mayde Creek High School 9th Grade Center, Taylor High School, and Taylor High School 9th Grade Center. Facilities, Planning, and Construction staff have worked closely with the Nutrition and Food Service Department (NFS) to develop and finalize the scope of component replacements needed to satisfy current needs. The current scope will include the design and coordination of the kitchen component replacement for a fee of 7% of the final construction cost. The kitchen equipment is being purchased separately using the Texas Department of Agriculture (TDA) funds.

This contract has been reviewed by the Districts legal counsel.Board approval of this request is consistent with Board PolicyCV(LEGAL)and CV(LOCAL).

Impact Statement: Approval of this recommendation at this time will enable equipment to be ordered and delivered to meet the projected August 2025 completion date.
